Competition entries are accepted on Friday evening between 6:30 and 8:00 PM and again on Saturday between 7:00 and 8:00 AM. Judging begins promptly at 8:15 AM so we will not take late competition entries. **ALL COMPETITION ENTRIES MUST BE CARVED FROM MARCH 2018 TO PRESENT, (WHICH ALLOWS A PIECE TO BE 2 YRS.OLD) BUT, NO REPEATS FROM LAST YEAR.** We will be having a buffet in the cafeteria on Friday eve around 5:00 for all exhibitors and those helping to set up the show for a nominal fee. (donations to offset costs accepted)

Notice to all exhibitors: The show is open Sat. 10am . 4pm and Sunday 10 am to 4pm and artists are expected to remain Set Up until Closing time.
